Key responsibilities

- Data quality assurance - you will use a systematic approach to review all products and recipes in our food and drink database to ensure they are accurately tagged. This will involve execution and evaluation of manual and automated quality assurance testing, identifying any potential quality issues per process and escalate concerns.
- System feedback - you will continuously undertake validation of the food database using a variety of software based tools and processes to ensure it accurately reflects primary data and dietary, intolerance and allergy categories appropriately. In addition, you will be familiar with EU food allergen legislation and product food labelling processes.
- Error resolution - you will work closely with the technical team to assess and resolve conflicts or errors. You will be required to feed back into the development cycle, facilitating continual improvement of the systems.
